## Improvements and New Features

- **DocAve version 4.1 to 4.5 upgrade tool**  
Note: All media servers and web servers must be upgraded to version 4.1.6.0 or above to run the updating tool.
- **DOC-2061: License expiration**  
A new notice has been added to alert DocAve owners of their expiring license, ensuring they have ample time to obtain a new license.
- **DOC-2126: Administrator Search Mode**  
The "Admin Search" and "Security Search" tabs at the top of the "Admin (search mode)" GUI have been moved to the "Search Criteria" area in order to reduce the number of required refreshes of the SharePoint tree.

## Bug Fixes

- **DOC-2085 : Search Criteria**  
The "Search Criteria" for the Administrator was adjusted to be *non*-case sensitive.
- **DOC-2133: Security Search**  
The user was previously unable to search on the folder level when the "Search Scope" was set to the library level.
- **DOC-2240: Log Shipping from Platform Recovery Fails**  
When using two farm environments, with the media and web installed on the same computer, if Platform Recovery was used to backup a database, and the "Sync Method" used under the High Availability backup was "Log Shipping from PR," the load would fail.
- **DOC-2109**

When running a backup plan at the site-to-site level, the task manager would show no progress in the status window, and only occasionally start the process.

- **DOC-2124**  
After selecting the download button in "Compliance Audit Report," a prompt would popup to install a Chinese language pack. The same popup would occur when "Show Chart" was selected in SharePoint "Locks & Quotas."
- **DOC-2161**  
After a sub-site was archived using the "Extension Archiver," the archived sub site could still be searched and indexed in the job monitor, but could not be restored.
- **DOC-2186**  
After backup data has been copied from another computer, the migration of that data to MOSS 2007 would fail at 0% completion.
- **DOC-2192**  
After building a site and creating a welcome page with SharePoint Server Publishing, once an out-of-place backed up of the site occurred, it could not be restored.
- **DOC-2194**  
When using the Archiver on extremely large jobs, the process would fail after thirty minutes without allowing the user to exit.
- **DOC-2208**  
If the client machine does not have Framework 2.0 installed, then the users should not be allowed to install the Server Package.

	DOC-2280	<b>Folder:</b> "Alert Me" After selecting "Edit Properties" for a specified folder and renaming it, the folder will no longer be able to be deleted.
<b>Compliance Archiver Search Mode</b>	DOC-2302	<b>Search criteria:</b> When using the "Search Criteria" combination of "Site Collection," "Specify Site Collection Template," an error will occur.

<b>Security Center Tree Mode</b>	DOC-1974	<b>Farm:</b> In the "Security Center," in tree mode, on the farm level, the web app cannot be set to "Predefined," "Network Service."
<b>Backup Migration</b>		Selecting one subsite and two sub-sites in the "Source" field and selecting one subsite in "Destination" results in the structure of the "Source" not being kept.
<b>'07 Auditor</b>	DOC-2317	When the user reloads a '07 Auditor plan, the loading tree will produce an error message.
<b>Extension Archiver</b>	DOC-2019	<b>Document Version:</b> "Restore" The major published document which was backed up in 4.5.0.0 cannot be restored after upgrading to 4.5.0.1000.
	DOC-2219	<b>Web Part Search:</b> After upgrading from DocAve 4.1 to DocAve 4.5, Extension Archiver's web part search needs to be reinstalled in the Agent Monitor.
	DOC-2366	<b>Web Part Search:</b> The Rule "Sampling and Content type" cannot be used in the web part search.
<b>Platform Recovery</b>		<b>Backup Builder:</b> When the Project Server is separated with web application host, it cannot save this plan if this is the only web application selected.
<b>High Availability</b>	DOC-2218	<b>Backup Builder:</b> The Sync Method "SQL Mirroring" is only supported for SQL server versions of 9.00.2047 and above.
	DOC-2277	<b>Backup Builder:</b> High Availability does not support a disk skip when running in Log Shipping from Platform Recovery mode. When the first disk is full, the job will fail.
